## NRCME Medical Review Board Membership Solicitation

FMCSA seeks 2 members to serve on its Medical Review Board, an advisory committee under the Federal Advisory Committee Act (FACA). MRB's 5 members provide FMCSA with medical advice and recommendations on medical standards and guidelines for the physical qualifications of operators of commercial motor vehicles (CMV). MRB members reflect expertise in a variety of medical specialties relevant to the driver fitness requirements of FMCSA. The FMCSA Administrator appoints members to 2-year renewable terms. MRB members serve as special government employees under FACA.

FMCSA is committed to ensuring MRB's diversity. Its membership shall include, to the extent practicable, individuals to represent persons with disabilities, as well as diversity of gender; geographic area; race and ethnicity; sexual orientation; medical expertise; and other factors to achieve the most diverse and comprehensive points of view.

To apply:

- 1) You must be a medical professional in a medical institution or private practice.
- 2) You must be a medical examiner in good standing on FMCSA's National Registry of Certified Medical Examiners.
- 3) Federal employees may not apply.
- 4) Please apply via email to [mrb@dot.gov](mailto:mrb@dot.gov) with the following 3 requirements:
  1. A current résumé showing relevant work history, including all medical certifications. This résumé must include your current mailing address and home address (if different) as well as a valid email address and phone number.
  2. A brief personal statement (2 paragraphs maximum) of why you wish to serve on MRB.
  3. One (1) letter of recommendation from someone who knows you and your work well. FMCSA will consider only one recommendation letter for each applicant.
- 5) FMCSA must receive complete applications by **COB, Monday, August 7**. Incomplete applications will not be considered.

## OSHA announces meeting of Federal Advisory Council on Occupational Safety and Health on July 13, 2023

**WASHINGTON** – The U.S. Department of Labor's Occupational Safety and Health Administration today announced a meeting of the Federal Advisory Council on Occupational Safety and Health on July 13, 2023, from 1 to 4 p.m. EDT.

FACOSH advises the Secretary of Labor on all matters relating to the occupational safety and health of federal employees. These matters include providing advice on how to reduce the number of injuries and illnesses in the federal workforce, and how to encourage federal executive branch departments and agencies to establish and maintain effective occupational safety and health programs.

The tentative agenda will include:

- The FACOSH subcommittee's work on addressing agencies' effective use of occupational safety and health management systems.
- OSHA's warehouse initiative.
- OSHA's work on workplace violence.

## Pregnant Workers Fairness Act

The Pregnant Workers Fairness Act (PWFA) is a new law that requires covered employers to provide “reasonable accommodations” to a worker’s known limitations related to pregnancy, childbirth, or related medical conditions, unless the accommodation will cause the employer an “undue hardship.” It went into effect on June 27, 2023.

- It is the first time that the USPSTF recommended anxiety screening for all adults aged younger than 65 years.
- The evidence was insufficient to recommend screening for anxiety among older adults.

## 2023 Scorecard on State Health System Performance

Every year, the Commonwealth Fund's Scorecard on State Health System Performance uses the most recent data to assess how well the health care system is working in every U.S. state. This year, Massachusetts achieved the best overall score, consistently placing among the top states on the seven dimensions of health system performance we evaluate. Hawaii, New Hampshire, Rhode Island, and Vermont round out the top five.

The lowest-ranked states overall are Arkansas, Texas, Oklahoma, West Virginia, and Mississippi.
