### In Memoriam: Dr. Brent Wayne Sanderlin

The AOCOPM is deeply saddened to announce the passing of longtime member Dr. Brent Wayne Sanderlin of Tomball, Texas, who died on June 17, 2025, at the age of 63.

Dr. Sanderlin served as Chair of Primary Care and Clinical Medicine and Associate Professor at Sam Houston State University College of Osteopathic Medicine since April 2023. He earned his DO degree from UNTHSC-TCOM, followed by internship and residency in Family Medicine with the US Navy, where he also served as a Naval Flight Surgeon.

His distinguished academic career included faculty positions at the University of the Incarnate Word School of Osteopathic Medicine, where he served as Associate Dean for Clinical Affairs, and at UNTHSC-TCOM teaching in their Family Medicine residency program. He maintained active clinical practice in Kyle and San Marcos, Texas, and briefly served as Chief Medical Information Officer at Seton Healthcare of Austin.

Dr. Sanderlin was a respected leader in professional organizations, including serving as president of the Texas Osteopathic Medical Association. With over twenty years in clinical practice, he was board certified in Family Medicine by both osteopathic and allopathic boards, as well as in Clinical Informatics. He held additional certifications in Occupational Medicine and Travel Health and served as an FAA Senior Medical Examiner.

His dedication to osteopathic medicine, medical education, and patient care will be deeply missed. The AOCOPM extends condolences to his family and colleagues.



# Amending the Medical Evaluation Requirements in the Respiratory Protection Standard for Certain Types of Respirators

via Federal Register

OSHA is proposing to remove some medical evaluation requirements in the Respiratory Protection Rule for certain types of respirators. This proposed change would only impact filtering facepiece respirators and loose-fitting powered air-purifying respirators.

Comments must be received on or before September 2, 2025.
